**100 YEARS AGO:**

**MARINES IN THE GREAT WAR**

**May 1917:** President Woodrow Wilson Issued an order that a Regiment of Marines will be sent for duty with the first elements of the AEF going to France. A large group of Marines, recently returned from Haiti, Santo Domingo, Cuba, off many ships of the fleet, and some reservists, assembled at the Philadelphia Navy Yard. This group would be formed into the First Battalion of the 5th Regiment of Marines. The Regiment would consist of three battalions of infantry, a headquarters company, and a machinegun company. Colonel Charles A. Doyen, USMC was the Regimental Commander. Major Julius S. Turrill would command the First Battalion. Many more Marines from Navy ships, posts in the U.S., and the first boot camp graduates joined the Regiment in Philadelphia. Marine Corps strength rapidly increased from the pre-war strength of around 20,000 officers and enlisted to well over 40,000.

**YOUNG MARINE REPORT by Kathy Winters**

On 22 April 2017, we initiated Camp Bonnyman, acreage set aside at Seymour Air Park for their use. We worked on outdoor skills and started construction on the obstacle course. With the help of Young Marine Dad Jon Crawford, an Air Force NCO with great survival training and skills, the Young Marines build 'hasty' shelters and learned other important elements of life in the woods. They completed a land navigation course. Between the raindrops, the Adults worked on the Obstacle Course building a climbing wall, a rope course, and other obstacles. Of course, the younger kids were more interested in climbing the huge pile of dirt that came off another job site that Mr. Winters is working on. Much thanks to Marine Scott Bailey, and other adults who worked all day helping us.

On 29 April, Unit Commander Larry Winters and XO Joe McCarter conducted our first rifle practice of the season. It was held at the new range and range house at Camp Bonnyman. There were eleven shooters. They will continue to compete for a place on the team that will go to the Tennessee Regimental Competition in Anniston, Alabama in August 2017.

Our Young Marines graduating from High School are required to leave the program. We held our ceremony on 13 May 2017 at 1500. We have five high school seniors retiring (leaving the program with more than 5 years or more). They have been great examples for our Community. They are: YM MGySgt Seth Gates (9 years), YM Msgt Gillem McMillen (5 years), and YM Staff Sergeant Alexander Farr (8 years). Those with less than five years in the program are honorably discharged. They include YM Sergeant Autumn Cox (2 years) and YM PFC Donovan Lowery (3 years). Collectively, they leave a big hole in our upper ranks. They will be missed and we wish them well in their future endeavors.
