VIETNAM MEMORIAL “WALLS THAT HEAL” IN KNOXVILLE

Our Detachment will participate in the presentation of the “Walls That Heal” in Knoxville on Sunday, 8 October from 1200 to 1600 at the Lynnhurst Cemetery. “Walls That Heal” is a replica of the National Vietnam Veterans Memorial in Washington D.C. and is presented at locations across the country to honor those who fell during the Vietnam War and to help heal those who fought and returned. Detachment members will participate in the 24 hour Vigil Watch at the memorial site on 8 October and will present a wreath to commemorate the names inscribed on the wall. **Howard Raines is the Detachment point of contact for any member wishing to participate in the vigil or ceremony on the 8th.** All Detachment members are encouraged to attend. The memorial can be visited at any time from 4 to 8 October.

100 YEARS AGO:

MARINES IN THE GREAT WAR

September 1917: The Marines were kept busy in training exercises supervised by the French Army. Subjects like field fortifications, trench mortars, flame throwers, and machinegun firing were emphasized by the French because of their continued belief that open, offensive warfare was a thing of the past and that the war would be won or lost in the trenches. Eventually, under General Pershing's guidance, training emphasis in the AEF would change to offensive operations.

Marines were often sidelined from training by the almost constant detachment of Marine companies for duty as service troops in rear areas. Marines served as guard detachments, on provost duty, and directing the movement of American troops through England and France. It seemed as though the Army leadership was trying to break up the Marine Regiments into small, scattered detachments in the hope that they would somehow disappear. Due to the surplus of senior officers, many Marine field grade officers were sent to Army training schools and were assigned to other headquarters and supply services throughout the AEF.

By the end of September, what was left of 5th Marines was transferred to the Bourmont training area. The rest of the Brigade would follow as they arrived from the U.S.

YOUNG MARINE REPORT by Kathy Winters

Following a very successful pistol match, August 16, 2017, at Camp Bonnyman, the Lt. Alexander Young Marine Color Guard presented the colors at the Friends of the NRA Banquet. This year, with the help of other Bonnyman Young Marines, we helped with games and selling tickets. The Friends of the NRA have been very generous in purchasing equipment for our Rifle Team. It was a very long day.

We squeezed in a Drill on August 23rd, getting back to basics. Mr. Winters and Mr. McCarter taught basic field skills, knot trying, and map reading. Mrs. Winters taught a DDR class based upon the dangers of mixing alcohol and drugs, even prescription medicine. We brought it home, as one of our former Young Marines committed suicide after this lethal combination. He had not been in our Unit long and had a very unfortunate family situation.

On Monday, August 25th, Virgil L. Young, Jr., notified us that he would be leaving the Young Marine Program, after almost 20 years of dedicated service. Not only does he leave our Unit, but he is our Regimental Commander, our Divisional XO, and our Schools Director. He leaves a big hole in the Program. The Winters honored him at the Marine Corps League meeting the next night. We wish him well in his future plans.

After a complicated process, we were granted permission from National Head Quarters, to induct an Honorary Young Marine. This fourteen year old is a Hospice patient. His caretakers contacted us. He is not expected to have a long life and wanted a career in the military. Colonel Bill Davis, CEO of the National Young Marines, wrote him a memorable letter and sent a Certificate naming him an Honorary Young Marine. He also sent his personal challenge coin, a Distinguished Order of Merit, and other gifts. Mr. and Mrs. Winters, along with YM SGT Holland and YM CPL Max Jones drove to Claiborne County to present this award. His caretakers and some family members were also present. As we left, YM SGT Holland, summed it all up, "I am so blessed."

On the 9th of September, we had our annual Aviation Day at Seymour Air Park. As it was a beautiful East Tennessee day, we had more pilots and planes than usual. All of the Young Marines, a few guests, and the Marine Corps I and I staff were able to fly. The Marines had a static display and allowed the kids to play and investigate their equipment. Food was prepared and served by Stephanie Bailey. After the planes left, we moved to the other end of the Airport to Camp Bonnyman, set up camp, and spent the night. MRE's and Smores were the hit. Of course, sausage and biscuits in the morning were better. Again, thanks to Mrs. Bailey. Now we look forward to the Marine Mud Run, the MCL picnic and The Wall That Heals.
